

In compliance with the French governmental recommendations concerning the fight against COVID-19, **Musicalta will ask you to present, at your arrival on the campus:**

- **either a vaccination certificate (2nd dose of the vaccine received more than 14 days ago)**
- **or a negative PCR or antigenic test for Covid-19 less than 48 hours old**
- **or a certificate of recovery less than 6 months old.**

We draw your attention to the fact that **without one of these certificates, you will not be allowed to enter our campus**. We also inform you that we will take your temperature at your arrival

Moreover, we will ask you to respect the social distancing measures as well as the other preventive measures (washing your hands regularly and wearing a mask), as soon as you are taken care of by our teams.

### 1. Legal framework

The legal framework is that of the decree n° 2021-699 of June 1, 2021 prescribing the general measures to manage the exit of the sanitary crisis which frames the activities of the collective receptions.

### 2. Housing conditions

- The accommodation premises are subject to a declaration to the departmental services for youth, commitment and sports (SDJES)
- The number of beds per room varies from 2 to 4. The beds are arranged in order to respect the distance of 2 meters between each headboard, and, if this is not possible, people will have to lie top to tail. Both bunks of a bunk bed may be used only if the persons are lying head to foot.
- The bedrooms will be ventilated several times a day, even continuously when possible.
- The premises will be cleaned in depth before the opening of the reception and accommodation facilities. The cleaning of the premises will be carried out using the usual procedures and products, with cleaning gloves. The floors and large surfaces (tables, desks) are cleaned at least once a day
- Disinfectant cleaning of the most frequently touched surfaces in rooms, workshops and other common areas (such as door handles) will be performed several times a day.
- Musicalta will provide soap and antibacterial gel in sufficient quantities.

### 3. Mask

- All supervisors and staff must wear a mask indoors. **The mask is mandatory indoors from the age of 6. It is not required outdoors.**
- As soon as it is mandatory, the mask must cover the mouth, the nose and the chin.
- When the activities are taking place indoors, it has to be changed every 4 hours or as soon as it is moist.
- **Students and staff members must bring a sufficient amount of masks and disposable tissues for the whole stay. These must be provided by the parents of the minor students and by Musicalta for the staff.**
- In case a minor student has forgotten, or doesn't have a sufficient amount of masks for the whole stay, Musicalta will make sure to provide them with.
- **We invite the legal guardians of minor students to explain to them the sanitary measures, and how to apply them.**

#### 4. Temperature control

- **All students and staff are invited to take their own temperature before their departure.** If the students are minor, their legal guardians are invited to take their temperature.
- In case of symptoms or fever (38.0°C or more), the person will not take part in the stay and cannot be accommodated.
- Likewise, people who have been tested positive to the Covid-19 or whose relatives have been tested positive, or who have been in contact with infected persons, won't be allowed to take part in the Musicalta Academy.
- Musicalta has thermometers to take temperature during the stay or in case of symptoms.
- **Temperature controls will be conducted at the arrival on the campus.**

#### 5. Activities

- Social distancing of at least 1 meter must be respected if possible during activities. If wearing a mask is impossible for some indoor activities, that social distancing must be of 2 meters.
- Physical and sports activities can be organized in compliance with the measures of physical distancing, hygiene, the regulations applicable to sports activities and the prescriptions of the *decree n° 2020-1310 of October 29, 2020 modified* prescribing the general measures necessary to face the epidemic of covid-19 within the framework of the state of health emergency.

#### 6. Food service

- Catering in the places provided for this purpose must be privileged.
- The organization of time and access to the catering areas will be designed to keep queues to a minimum.
- The organization of the catering time will make it possible to limit the elements used in common which can facilitate the contacts and the assemblies.
- A distance of 2 linear meters between tables will be maintained.
- Disinfection of tables and chair backs will be done after each meal.

#### 7. Case of a student or staff member showing symptoms of Covid-19

- **Any symptom suggestive of Covid-19 infection noticed by Musicalta or by the person, will lead to his isolation in an adapted place.**
- Medical care will be arranged without delay. In the case of a minor student, his/her legal guardians will be notified and will have to come and get him/her. His/her departure will be organized in such a way as to avoid any proximity with other minors. If the legal guardians are unable to pick up the minor, the organizer will ensure, in conjunction with them, the return of the minor in compliance with the prescriptions of the health authorities.
- If a supervisor or a staff member shows a symptom suggestive of an infection to Covid-19, he/she will be isolated and will have to return home.
- The operational process of follow-up and isolation of contact or confirmed cases will then be implemented according to the prescriptions defined by the health authorities. Contact tracing will identify if students or other personnel are to be considered as at-risk contacts in compliance with the rules related to the wearing of masks, barrier measures and physical distancing.
- The decision to suspend the stay is determined according to the situation and an analysis shared by the various actors involved in the management of the situation: Musicalta, the services of the regional health agency (ARS) and the prefecture.
